Introduction to Company D

Company D, Marine cryptologic Support Battalion (MCSB) is part of the Army post Fort Gordon, Georgia. Ft. Gordon is located in the metropolitan area known as Augusta, Ga. Company D is a subordinate company of MCSB, located at NSA Washington (NSAW) in Ft. Meade, MD. The Company is also a tenant command of NSA/CSS Georgia (NSAG).

NSAG is a joint command, meaning that it is staffed by all four branches of the DoD, as well as the Coast Guard, and civilian contractors. Member nations of the Five Eyes (FVEY) intelligence alliance. NSAG provides support to the global mission on terrorism.

The installation is centrally located among several points of interest. It is a short drive to cities such as Atlanta, Ga to the west and Savannah, Ga or Myrtle Beach, SC to the east.

Reporting for Duty

All Marines will report in Service Alpha uniform to the Company D office in building 28431 during regular duty hours (0700-1630, Monday-Friday). Additionally, if you arriving during non-duty hours, call the Officer of the Day (OOD) at (706) 831-5567

Uniforms

The prescribed uniform of the day for Company D Marines is the Desert MARPAT (sleeves up) during summer months and Woodland MARPAT during winter months. Last Friday of every month, the uniform of the day is the respective Service uniform.

Schools and Education

Child Education

Ft. Gordon is located on the border of multiple counties, therefore the schools children will attend depends upon where the address is located in relation to those counties.

Higher Education

The Central Savannah River Area (CSRA) offers many opportunities for higher education. Many colleges as well as Technical Schools operate in the CSRA. <u>Augusta University</u> offers a health and medical program that is well known throughout the industry. Motor Vehicle Registration

Registration of POVs on post is no longer required. However, all persons entering the gates should have their CAC or ID cards registered with Automated Installation Entry System (AIES) to expedite entry. Georgia law allows military personnel to license and register their vehicles in the state without becoming Georgia residents. This may be beneficial in that military personnel do not have to pay any taxes as nonresidents, only a tag fee which is typically \$20.00.

Nonresident military personnel can also obtain a Georgia Driver's license without becoming a resident. No driving or written test is required, only an eye test.

To receive a license, the applicant must be at least 16 years old and must have held an instructional permit for one full year. Applicants for an instructional permit must be 15 years. Applicants under the age of 17 must successfully complete a driver education course approved by the Department of Driver Services. All applicants, regardless of age, must also complete a total of at least 40 hours of supervised driving experience, including at least six hours at night.

All teenagers **under the age of 18** must complete and pass the Georgia Alcohol Drug Awareness Program (ADAP) in order to receive their driver's license. This course is taught in both public and private schools in four one-hour sessions.

Forms needed for obtaining a Georgia driver's license can be obtained on the DMV website

Unaccompanied Marines E-5 and below will check-in to the BEQ on Fort Gordon upon arrival.

Unaccompanied Marines E-6 and above will be authorized Temporary Lodging Allowance (TLA) during their search for housing. Once they have acquired housing, they will rate BAH w/o dependents for the local rate.

All accompanied Marines qualify for housing and/or TLA with the Fort Gordon Family Housing, managed by Balfour Beatty Communities.
