

MAJOR ROBERT D. REAGLES COMMANDING OFFICER COMPANY H UNITED STATES MARINE CORPS

Robert Reagles enlisted in the Marine Corps Reserve in July 2004. Upon graduation from recruit training at Marine Corps Recruit Depot San Diego, he attended Marine Combat Training. Upon completion, he was assigned to Marine Wing Support Squadron (Det -) in Minneapolis, Minnesota, from 2004 to 2006. During this

period, he deployed in support of Operation SEA BREEZE to the Ukraine for bilateral training.

Robert Reagles graduated from Bethany Lutheran College in Mankato, Minnesota, and was commissioned a Second Lieutenant in 2006. He completed The Basic School, Infantry Officer Course, and Ground Intelligence Officers Course and was assigned to 2d Intelligence Battalion. Second Lieutenant Reagles was assigned to a Military Transition Team and deployed in support of Operation IRAQI FREEDOM from July 2008 to July 2009. During this time, he advised Iraqi Police, Directorate General of Intelligence and Security, Port of Entry intelligence agencies in Anbar Province and the 52nd Iraqi Army Brigade in Basra, Iraq.

After returning to 2d Intelligence Battalion in August 2009, he assumed command of 2d Ground Sensor Platoon and trained Sensor Employment Teams to support OEF and MEU tasked units. In December 2009 to March 2010, First Lieutenant Reagles led a sensor and GEOINT detachment in support of Operation GREEN FLASH at the Brown Field Customs and Border Patrol Station along the California/Mexico Border. During this time, the Intelligence Detachment supported counter drug operations and surveillance of border crossing points. In May of 2010 First Lieutenant Reagles reported as the Assistant Intelligence Officer for 6th Marines, he was promoted to Captain and re-assigned to 1st Battalion, 9th Marines in October 2010 as the Battalion Intelligence Officer. In May of 2011, Captain Reagles deployed with 1st

Battalion, 9th Marines in support of Operation ENDURING FREEDOM to Nawa Afghanistan. Post the OEF 11.2 deployment, Captain Reagles was selected on the Commandants Career Level Education Board (CCLEB) and assigned to Expeditionary Warfare School (EWS) in July 2012 to June 2013.

Post EWS, Captain Reagles was assigned to the 15th Marine Expeditionary Unit (MEU) as the Assistant Intelligence Officer. He supported several TSC exercises within CONUS to include IRON FIST, AQUA TERRA, PANAMAX, and RIMPAC where he served as one of the lead planners for the 15th MEU. From May 2015 to December 2015, he deployed with the 15th MEU ISO WESTPAC 15-1 and was selected to be an Advisor Team OIC and lead Intelligence Advisor assigned to Joint Coalition Planning Cell supporting a GCC partner from July 2015 to November 2015. Upon completion of the deployment, Captain Reagles returned to the 15th MEU was promoted to Major and reported to Company H, Marine Cryptologic Support Battalion in San Antonio, Texas in July 2016.

He is married to his wife Amber and they have three children; Hailey (7 Years), Alivia (4 Years), and Caleb (19 Months).
