Career Progression within the 0081 Occupational Series is Marked by Advancing Levels of Expertise in Matters of Firefighting

GS-0081-3/6 Entry Level (Apprentice)

Description:

Typically, GS-03 firefightertraining assignments include primarily formalized classroom study, on-the-job instruction, practice drills and demonstrations. Training includes general theory and methods appropriate for all types of standard firefighting, prevention, and rescue methods and techniques with emphasis on specialized procedures and techniques required at the installation.

OPM Qualifications:

General Experience (for GS-3 positions):
 Work experience or military service that
 demonstrated the ability to follow
 directions and to read, understand, and

 regulations, and procedures and that
 otherwise demonstrates the ability to

G S-0081-7/9 Full Performance (Journeyman)

Description:

In addition to the firefighting and first responder duties and responsibilities positions at this level follow protocols in providing basic life support or ALS. Possesses knowledge and understanding of relevant techniques and procedures and is able to apply them with some help and guidance.

OPM Qualifications:

➤ Experience that demonstrated the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position. Such duties may include (1) controlling or extinguishing fires as a member of an organized military, industrial, volunteer, or governmental fire department or brigade; (2) rescue operations; (3) detection, reduction, or elimination of potential fire hazards; (4) operation of fire communications equipment; (5) controlling hazardous materials incidents and/or (6) developing, implementing, or providing training in fire protection and prevention.

OR

- 1 year of specialized experience equivalent to at least the next lower grade level.
- Incumbent must also pass all applicable physical/medical tests and possess a valid drivers license.

Such duties may include (1) controlling or extinguishing fires as a leader of an organized military, industrial, volunteer, or governmental fire department or brigade; (2) rescue operations; (3) detection, reduction, or elimination of potential fire hazards; (4) operation of fire communications equipment; (5) controlling hazardous materials incidents and/or (6) developing, implementing, or providing training in fire protection and prevention.

Description:

OPM Qualifications:

➤ Experience that demonstrated the particular knowledge, skills, and abilities (KSA's) to perform successfully the duties of the position. Such duties may include leads members of an organized military, industrial, volunteer, or governmental fire department or brigade to (1) control or extinguish fires; (2) rescue operations; (3) detection, reduction, or elimination of potential fire hazards; (4) operation of fire communications equipment; (5) controlling hazardous materials incidents and/or (6) developing, implementing, or providing training in fire protection and prevention.

OR

- 1 year of specialized experience equivalent to at least the next lower grade level.

Different jobs require different levels of proficiency for successful performance.

Career progress in the USMC has traditionally been based on the Federal Government pay schedule system and the ranges within the pay schedule system are associated with the Skill Levels.

* = Table reflects the minimum qualifications. Incumbents in parenthetical positions must also satisfy the certification requirements and firefighter duty position they hold. For example, a firefighter (paramedic) filling a crew chief position must meet the certification requirements for crew chief.

Notes:

- 1. This chart depicts the minimum certification requirements to occupy positions indicated. Local managers determine additional training and certifications for service- or installation-specific missions
- 2. Time in grade is based on firefighter duties. Grades based on parenthetical duties do not satisfy time in grade requirements. For example, a GS-9 firefighter (paramedic) that would otherwise be a GS-6 firefighter will not meet time in grade requirements for a GS-10 firefighter position even though they may have one year experience as a GS-9 firefighter (paramedic).


