PROVISIONS OF THE PUBLIC LAW TO BE ISSUED A CREDENTIAL TO CARRY A

CONCEALED FIREARM. EFFECTIVE DTG OF THIS MSG, LAW ENFORCEMENT

BATTALION COMMANDERS ARE AUTHORIZED TO ISSUE LEOSA 926B CREDENTIALS

TO QUALIFIED MILITARY POLICE (MP) IAW REF (C). APPOINTED PROGRAM

MANAGERS MUST HAVE COMPLETED CREDENTIAL MANAGER TRAINING OFFERED IN

REF (D) TO ENSURE COMPLIANCE TO THE GUIDELINES STIPULATED IN REF (C).

1.A. PERSONNEL GRANTED LEOSA PRIVILEGES WILL ADHERE TO MCICOM POLICY WHICH PROHIBITS CARRYING CONCEALED WEAPONS ABOARD BASES.

1.B. COMMANDERS ARE REQUIRED TO PROVIDE POC2 ABOVE WITH A COPY OF THEIR RESPECTIVE PROGRAM MANAGERS APPOINTMENT LETTERS IN ORDER TO FACILITATE DELIVERY OF REQUIRED CARDSTOCK.

1.C. MARINES SERVING IN LAW ENFORCEMENT INTEGRATION BILLETS MAY BE ISSUED LEOSA CREDENTIALS FROM THE LE BATTALION OR THEY MAY APPLY DIRECTLY TO HQMC LEOSA PROGRAM MANAGER FOR THEIR CREDENTIALS.

2. ALL OTHER FIREARM POLICIES REMAIN IN EFFECT. ADDITIONAL
