- i. Summary of FAO Oriented Experience.
- (1) From (MCSF) Company Guantánamo Bay. While appointed to this billet, I was the installation commander's senior advisor for security matters. I was assigned an area of operations (AO) that encompassed two-thirds of the grounds leased to the US Government and was responsible for directing all naval external security for shore side operations, which required frequent coordination with USN and USCG security forces and operational control of USN units during contingency operations. This billet also required frequent interaction with Cuban officials, which included: reviewing Cuban communiqués and proposing responses by the installation commander; attending meetings with Cuban officials; directing the daily perimeter passage of Cuban nationals; and planning and executing combined USCuban exercises.
- (2) As the senior USMC representative, I participated in 32 formal military-to-military engagements between US and Cuban officials to address local security matters, migration concerns, and to conduct exercise planning. Half of these meetings were convened in a US facility and half were held in a Cuban facility. Cuban officials were comprised of general and field grade officers and government officials of the Ministry of Foreign Affairs. I accompanied the installation commander, USMC intelligence personnel, and representatives from the Department of State (DOS) and the Department of Homeland Security (DHS).
  - directed external security tasks for three combined US-Cuban exercises. Before my transfer, I participated in planning and directing mobility preparations for a fourth exercise, which included the first coordinated US motor vehicle passage off the installation and into the Cuban security zone since 1958. The exercises included three installation tenant commands, uniformed and civilian officials, and their respective Cuban counterparts. The purpose of the exercises was to rehearse combined responses to a mass casualty crisis. Exercise tasks for my command included: site security; checkpoint operations; and coordinating/de-conflicting cross boundary movements of aircraft and vehicles. Cross boundary movement included Cuban soldiers entering the Naval Station and US service members departing the installation to rehearse actions on opposite sides of the perimeter.
  - (4) The diplomatically sensitive issue of migration required frequent interaction with military and government officials. From MCSF apprehension of numerous persons intruding onto the installation to the repatriation of 250 Cuban nationals, intrusions and migration matters required at least monthly interaction with DOS and DHS representatives and with Cuban officials. For steady state migrant operations, I participated in devising coordinated security responses with the International Organization for Migration's Chief of Mission in Cuba. For mass migration operations, my command facilitated installation and JTF Guantánamo planning.
  - (5) Due to concerns regarding mass migration, detention operations and the succession of Cuban authority, I conducted numerous orientations of my AO and current operations briefs to several senior leaders and planners from various departments. Officials included the Secretary of Commerce; Director, NCIS; Head of Office, Cuban Affairs, DOS; and numerous flag officers. I also conducted tours for regional representatives of international nongovernmental organizations and journalists.

- (6) From June to May (1), I attended the WHINSEC Intermediate Level Education (ILE) Course. All course instruction and written/oral assessments were conducted in Spanish. The preponderance of the curriculum was instructed by Latin American field grade officers, representing eight countries. My class was composed of students from seven countries and one-third of the students were foreign officers from Latin America.
- (7) In July , I completed all course ware and comprehensive examination requirements for a Master of Science in International Relations with a National Security Affairs concentration from Troy University.
