## Security Note 02-13

Subj: PERSONNEL, PHYSICAL, INFORMATION AND COMMUNICATIONS SECURITY SYSTEM (PPICSS) DEPLOYMENT AND IMPLEMENTATION

Ref: (a) SECNAV M-5510.30

- 1. <u>Situation</u>. The Security Programs and Information Management Branch (ARS) will deploy and implement use of the Personnel, Physical, Information and Communications Security System (PPICSS). PPICSS is a CAC-enabled, single-source-solution, for security program management and support services. PPICSS is designed to incorporate security management policy while meeting the varying needs of HOMC customers.
- 2. Mission. PPICSS will accomplish the following:
- a. Automation of Personnel, Physical, Information and Communication security service requests. These requests include but are not limited to:
  - (1) Personnel security investigations
  - (2) Safe and lock service
  - (3) Communication equipment issuance
  - (4) Personnel check-in
  - b. Classified material accountability and control.
  - c. Annual training.
  - d. Secured and encrypted maintenance of personnel e-records.
- 3. <u>Execution</u>. PPICSS requires account registration and activation. ARS will facilitate all Security Coordinator accounts. Security Coordinators will facilitate all user accounts within their agency/activity. Security Coordinators will receive PPICSS training on the following dates:
  - 4 March 2013 0900 1000
  - 4 March 2013 1300 1400
  - 6 March 2013 0900 1000
  - 6 March 2013 1300 1400

Subj: PERSONNEL, PHYSICAL, INFORMATION AND COMMUNICATIONS SECURITY SYSTEM (PPICSS) DEPLOYMENT AND IMPLEMENTATION

Security Coordinators may register for training by sending an email to <a href="mailto-orlando.roman@usmc.mil">orlando.roman@usmc.mil</a>. Security Coordinators should register as early as possible, as seating is limited. Security Coordinators will begin using PPICSS on 7 March 2013 for all security service and support requests.

- Administration and Logistics. All HQMC military, civilian and contractor personnel are required to maintain an e-Record within PPICSS. PPICSS will rely on data stored within e-Records to initialize security service requests. ARS will not be able to provide security service to personnel who do not possess a valid e-Record in PPICSS. Personnel will also have the opportunity to complete annual training and upload completion certificates directly into PPICSS; eliminating the requirement to track training completion manually. PPICSS will replace the Electronic Security Service Request Portal (ESSRP) and the Classified Document Control Catalog (CDCC). To ensure degradation of security service support does not occur, ESSRP will remain online during March 2013. CDCC will remain online until PPICSS has accurately captured all classified inventory information. PPICSS can be accessed at: https://ppicss.hqi.usmc.mil/IPCPSP. PPICSS helpdesk support will be available during normal business hours at (703) 614-3609.
