For conspicuous gallantry and intrepidity in action while serving as Platoon Leader, Company K, 3d Battalion, 1st Marine Division on Guadalcanal, British Solomon Islands. On 13 and 14 September 1942, Second Lieutenant Abady's platoon was deployed straddling an overland trail and bore the brunt of the attack on the company's positions from a detachment from the Japanese Army's Kuma Battalion whose objective was Henderson Field and the 1st Division Command Post which were located approximately a half mile to the rear. Enemy Japanese soldiers with fixed bayonets penetrated the barbed wire less than 200 feet in front of the platoon's position, and entered the unit's foxholes where vicious hand-to-hand combat ensued. At one point, Second Lieutenant Abady took a position behind a banyan tree and succeeded in killing several Japanese soldiers with his .45 caliber pistol. As a result of his direction and encouragement, the Marines held their positions against the intense enemy onslaught and kept the enemy from reaching their objective. At daybreak, some 30 bodies of enemy soldiers lay around the platoon's defensive positions and an additional 30 bodies were entangled in the barbed wire in front of the platoon's position. By his extraordinary heroism, superb courage, and loyal devotion to duty, Second Lieutenant Abady reflected great credit upon himself and upheld the highest traditions of the Marine Corps and the United States Naval Service.

By his daring initiative and bold fighting spirit in the face of grave peril, he contributed essentially to the withdrawal of the enemy and his unwavering devotion to duty was in keeping with the highest traditions of the United States Naval Service."

PRIVATE LLOYD B. ABBOTT, USMCR., 470594

"For gallantry in action at Enogai, New Georgia, Solomon Islands, on 7 July 1943. In attacking a strong Japanese defensive position, all of the other men in his squad suddenly were pinned down by heavy enemy fire. Determined to continue the charge, Private Abbott pressed forward alone and succeeded in establishing an advanced position. His gallant action encouraged the other men to quickly follow and push the advance he had started, forcing the enemy to give ground and begin their withdrawal. In delivering the final blow, Private Abbott lost his life."

"For conspicuous gallantry and intropidity while serving as a Fire Team Leader of Company A, First Battalion, Twenty-fifth Marines, Fourth Marine Division, in action against enemy Japanese forces on Two Jima, Volcano Islands, 19 February 1945. When his platoon's advance was halted by intense hostile machine-gun fire, Corporal Abel coordinated an assault by moving his group into firing position and directed the attack from the top of a knoll despite intense enemy mortar fire. Although severely wounded, he gave first aid to two comrades and, when his platoon was endangered by a depleted ammunition supply, crewled twenty-five yards under fire to replenish the stock, thereby contributing materially to the success of the mission in which two machine guns and a light mortar were destroyed and five Japanese killed. His courage, leadership and devotion to duky were in keeping with the highest traditions of the United States Maval Service."

After dis-embarking assault troops on the beavily fortified beachboad on D-Day, Private First Class Abernathy boldly returned to the edge of a treacherous coral reef to assist other units balted in the water by the enemy's concentrated shellfire. Using his tractor as a shield by driving between the gunfire and the troops, he effectively covered their advance to shore and, at the same time, skillfully manned his vohicle's monnted machine gun to deliver destructive return fire against the fanatic Japanese, Upon reaching the beach, he dauntlessly continued in the fight, providing overhead fire for oncoming troops until his tractor was completely demolished by a bursting Japanese shall. By his prompt and daring action, bis great personal valor and zealous devotion to duty in the face of tremendous odds, Private First Class Abernathy contributed materially to the success of our forces in capturing this vital hostile stronghold, and upheld the highest traditions of the United States Naval Service."

"For conspicuous gallantry and intropidity while serving with Company A, First Battalion, Twenty-fifth Marines, Fourth Marine Division, in action against enemy Japanese forces on Iwo Jima, Volcano Islands, 19 February 1945. Landing with the first wave of infantry on D-Day, Private Acquaviva advanced inland with his company a distance of thirty yards when taken under intense artillery, mortar, rocket, machine-gun and rifle fire which halted his company's advance in the vicinity of the railroad tracks. In company with another member of his squad, he courageously and voluntarily crept forward to this enemy position and observed five or six Japanese in a dugout. With the hostile troops hurling hand grenades at them, Private Acquaviva killed one of the enemy as he arose to fire and then charged into the enemy position. Although a hand grenade exploded between his legs as he was running towards the dugout, he hurled another grenade into the dugout, killing the remaining Japanese and eliminating this position. By his cool and gallant action, Private Acquaviva enabled his company to continue the advance, and his courage, initiative and selflessness during this action were in keeping with the highest traditions of the United States Naval Service.

Crossing the river and establishing a position from which he was able to fire on the Japanese who had captured one of our machine guns, Private First Class Adami greatly assisted in the retaking of the emplacement. Subsequently observing a saverely wounded comrade some distance away, he unhesitatingly made his way across an open area continually exposed to hostile small arms and grenade fire to ald the helpless Marine, but was himself mortally wounded. Private First Class Adami's courageous devotion to duty, indomitable fighting spirit and self-sacrificing efforts on behalf of another were in keeping with the highest traditions of the United States Naval Service. He gallantly gave his life for his country."

Volunteering to construct an approach to a hostile pocket of resistance in order that a tank company might destroy this strong point, Sergeant Adams maneuvered his lightly-armored and unarmed bulldozer deep into enemyheld territory and succeeded in building an approach which was about four hundred yards in length, constantly leading the tanks and infantry. "For conspicuous gallantry and intrepidity while serving with the Fourth Marine Division in combat against enemy Japanese forces during the invasion of Namur Island. Kwajalein Atoll, Marshall Islands, February 1, 1944. Although his post as police sergeant did not require it, Platoon Sergeant Adams joined his comrades in the front lines and fought with skill and courage to dislodge the enemy from their entrenched positions along the northern beach of the island. On one occasion he and another Marine assaulted a connected series of trenches and a pillbox by alternately attacking the Japanese and acting as cover for each other until reaching positions approximately ten yards from the enemy emplacement. Fearlessly exposing himself to the Japanese, Platoon Sergeant Adams succeeded in destroying five of the hostile troops before he, himself, was killed. His extreme bravery and tenacious determination were an inspiration to his comrades and in keeping with the highest traditions of the United States Naval Service. He gallantly gave his life for his country."

"For conspicuous gallantry and intrepidity as a Machine Gun Squad Leader while serving with Company L. Third Battalion, Twenty-fourth Marines, Fourth Marine Division, during operations against enemy Japanese forces on Salpan, Marianas Islands, from 15 June to 9 July 1944. When hostile machine-gun fire wounded the men carrying the gun as Corporal Adams led his squad in an attack on a strongly defended enemy position, he courageously crawled forward alone, although he had been wounded twice, in an attempt to recover the gun from its exposed position. While he was attempting to reach the weapon with a length of wire, an enemy land mine, afmed at him, exploded and partially demolished the gun. Refusing to be evacuated, Corporal Adams returned to the front lines and joined in the attack, sustaining two more wounds before he was ordered to the rear. By his leadership, initiative and devotion to duty, he contributed materially to the success of this vital campaign and upheld the highest traditions of the United States Naval Service."

When an infantry battalion was subjected to intense hostile fire during unloading operations, Private Anthony unhesitatingly volunteered to advance beyond the beachhead and attempt to silence the enemy gun emplacements. Despite a withering hail of hostile machine-gun and rifle fire, he courageously proceeded beyond the foremost elements of combat troops and, with several comrades, attacked and destroyed seven vital enemy positions, killing fourteen Japanese and driving out numerous others. By his daring initiative, he and his companions were able to capture hostile documents containing valuable military information for our forces. Private Anthony's aggressive fighting spirit and valiant conduct in the face of grave peril were in keeping with the highest traditions of the United States Naval Service."
