When a hostile patrol attacked and wounded several defenders of the Company Command Post, Gunnery Sergeant Estelle crawled from his foxhole, proceeded toward the enemy through an area where both friendly and hostile grenades were falling and, rushing the enemy position, killed three Japanese riflemen. Proceeding around to the rear of the Command Post toward the 60-mm. mortar position where a renewal of the fire fight had attracted his attention, he killed another member of the hostile patrol and, still unsatisfied that the enemy had all been killed or had withdrawn, continued to search through the entire area before reporting back to the Command Post. His outstanding initiative and courageous devotion to duty in the face of enemy fire were in keeping with the highest traditions of the United States Naval Service."
