Setting up his machine gun in the face of intense hostile fire during a fierce enemy attack on his battery's position, Private First Class Naber delivered effective fire until his gun ceased to function. Leaving his position, he borrowed a machine gun from an adjacent unit and set it up in an exposed position from which he could cover the evacuation of the wounded and the withdrawal of isolated elements. When reinforcements arrived, he advanced with them, directing their movements and pointing out targets. His great personal valor, deep concern for his comrades and complete disregard for his own safety reflect the highest credit upon Private First Class Naber and the United States Naval Service."

He gallantly gave his life for his country."

In order to lay a telephone trunk line to Headquarters after all others had been destroyed, Major Narter led out a wire crew of the Headquarters and Service Company, Fifth Marines, First Marine Division, following heavy Japanese naval bombardment. During construction of the circuit, the crew was caught in the open and exposed to hostile bombing on five separate occasions. However, despite this hazardous distraction, at no time did the personnel scatter or suspend their activities. Under Major Narter's courageous and aggressive leadership, they were able to complete their mission before daylight and thus establish the only means of wire communication from Headquarters to the Base Radio and other important units."

Assuming an exposed position on the lighter's gunwale despite a fierce barrage of hostile mortar and artillery fire emanating from the beach, he steadfastly continued his determined efforts until a hostile shell struck the vessel, setting it afire and instantly killing the crew on the starboard side of the lighter. His daring initiative, great personal valor and cool courage in the face of grave peril reflect the highest credit upon Private First Class Nations and the United States Naval Service. He gallantly gave his life for his country.”

During a determined attempt of the enemy to seize the Guadalcanal airport, Major Nees, with utter disregard for his own personal safety, took over an observation post a few feet from the front line. Later volunteering to execute several highly important missions under intense fire, he courageously led various units into position, located groups of the enemy and guided attacks against them. Second Lieutenant Neugent's splendid initiative and valiant devotion to duty throughout this period of vital offensive operations were in keeping with the highest traditions of the United States Naval Service."
