When a bursting artillery shell hit near by and blew two Marines from their foxholes onto the open ground, Private First Class Yoakum heard the cries of the wounded men above the terrific noise created by the furious shelling and, unhesitatingly leaving the comparative safety of his own foxhole, braved a deadly rain of bullets in a valiant effort to rescue his companions. By his courageous initiative, outstanding fortitude and concern for the safety of others in the face of grave personal danger, Private First Class Yoakum contributed to the saving of two men who otherwise might have perished, and his heroic conduct and selfless efforts throughout reflect the highest credit upon himself and the United States Naval Service. He gallantly gave his life for his country."

Observing that a rifle platoon in the company had become disorganized due to casualties, Second Lieutenant Young assumed command of the unit in the face of intense fire and, after reorganizing it, made a reconnaissance under heavy fire, thereby finding a route of approach into the enemy position. Attacking with his platoon, he neutralized the bunkers with explosives and, annihilating at least fifteen of the Japanese in the foxholes, continued until he had secured the ridge to the rear of the hostile position. After setting up a defense, he went forward one hundred yards with a runner to determine which were enemy-held positions, thus aiding his company in the successful advance the following day. His leadership, courage and de-votion to duty were in keeping with the highest traditions of the United States Naval Service."

When a friendly Navy float-type plane was hit and crashed behind Japanese lines, First Lieutenant Young voluntarily led a resoue party which moved rapidly three hundred yords through hostile territory to the wreckage. Despite the imminent threat of an explosion from high octane gasoline which covered the immediate area and the constant danger of enemy ambush, he unhesitatingly risked his life to extricate two seriously injured members of the crew trapped in the wreckage. Landing in an area which was being subjected to a heavy barrage of enemy rifle, mortar and machine-gun fire, Captain Young found that his rifle company had intermingled with another unit which had previously landed. Despite the hostile fire, he moved from platoon to platoon, issuing orders and providing the necessary incentive to enable his men to move forward and clear the extremely dangerous beach sector. Shortly afterwards, despite grievous shrapnel wounds in the arm and back, Captain Young succeeded in assembling his company in the battalion area and directed the establishment of an effective night defensive position. Although suffering from his wounds, he summoned his Platoon Leaders on the following morning, briefed them in the plan for the continuation of the attack on Mount Suribachi and moved forward with his assault platoons. Wounded very seriously in the chest during this advance, he retained consciousness and transferred his company to his second in command. His skilled leadership, unselfish courage and devotion to duty were in keeping with the highest traditions of the United States Naval Service."

When his platoon leader became a casualty during a furious engagement with the enemy on 27 February, Sergeant Young promptly assumed command and, fearlessly leading his men in repeated aggressive attacks during the sustained advance of our forces, contributed materially to the success of his company in overcoming fierce hostile resistance. Driving forward against an objective vital to the defense of his sector the night of 1 March. he led his clatoon through onehundred yards of shattering machinegun fire and, launching a determined strike, gained his position with a minimum of casualties among his men. With his platoon pinned down during a fierce action on 6 March, he continued his same daring tactics and, penetrating hostile fire lanes alone to locate the source of the deadly barrage, directed supporting weapons in eliminating the stronghold before he was fatally struck down by a sudden shellburst. Sergeant Young's forceful and inspiring leadership, bold initiative and valiant devotion to duty in the face of tremendous odds were essential factors in the success of the bitterly fought Iwo campaign and reflect the highest credit upon himself and the United States Naval Service. He gallantly gave his life for his country."
