



### **VA MISSION ACT OF 2018**

### **Veterans Community Care - Urgent Care**

Beginning June 6, 2019, under the MISSION Act, Veterans will have more ways to access health care. As part of implementing the VA MISSION Act of 2018, the VA will offer an Urgent Care bene-

fit that provides eligible Veterans with greater choice and access to timely high-quality care.

This includes care within the VA's network and through approved non-VA medical providers within the Veteran's community called "community care providers." Depending on a Veteran's situation - for example, if a certain type of health service isn't provided by the VA—a Veteran may be able to go to a non-VA provider, using their VA coverage. With Urgent Care, Veterans have a new option of care for the treatment of minor injuries and illnesses, such as colds, sore throats, and miner skin infections. This benefit is offered in addition to the opportunity to receive care from a VA provider, as the VA also offers same-day services.

The VA will **only pay** for care under this benefit if:

- The Veteran is eligible.
- The medical services are not excluded under the benefit.
- The provider is part of VA's contracted network of community providers and is identified as an Urgent Care provider.

If an eligible Veteran goes to an out-of-network urgent care provider, they may be required to pay the full cost of care. By law the VA cannot pay claims for Urgent Care rendered to a Veteran from providers that are not part of the VA's network.

### **Eligibility**

Veterans should contact their local VA medical facility to see if they are eligible.

To find an available Urgent Care provider in VA's contracted network of community providers, Veterans can use the VA's provider locator on VA.gov (<a href="https://www.va.gov/find-locations/">https://www.va.gov/find-locations/</a>) or contact their local VA medical facility. VA staff can inform the Veteran of available in-network locations and offer to find the closest locations. If a Veteran arrives at an Urgent Care network location and has any difficulty receiving care, they can call the VA Urgent Care support line (866) 620 - 2071 for assistance.

### **CRDP & CRSC (2019)**

There are two concurrent receipt programs available to Navy and Marine Corps retirees who have VA rated disabilities. They are the Concurrent Retirement and Disability Pay (CRDP) program and the Combat Related Special Compensation (CRSC) program. Retirees who receive VA disability payments may have their retired pay "offset" (reduced) by the amount of VA pay. These concurrent receipt programs "restore" some or all of that retired pay.

The Defense Finance and Accounting Service (DFAS) calculates and pays monthly CRDP and CRSC compensation. It is highly recommended that you have a MyPay account set up with DFAS to manage your retired pay: <a href="http://www.dfas.mil/retiredmilitary/manage/mypay.html">http://www.dfas.mil/retiredmilitary/manage/mypay.html</a>

In order to be eligible for these programs, disabled retirees <u>must be eligible for retired pay AND be in receipt of VA disability compensation</u>. Medical retirees (TDRL & PDRL) with less than 20 years service are eligible for CRSC only. Twenty year and Temporary Early Retirement Authority (TERA) retirees (15-19 years of service) and Reservists (age 60) are eligible for both CRSC and CRDP, but can receive compensation from only one program. CRSC claimants must apply to the Service CRSC Board from which they retired. <a href="http://www.secnav.navy.mil/mra/CORB/Documents/dd2860.pdf">http://www.secnav.navy.mil/mra/CORB/Documents/dd2860.pdf</a>

CRDP is automatic and is paid to 20 year and TERA retirees who have VA rated service connected disabilities of 50% or higher total percentage. There is no application required, nor accepted. DFAS determines eligibility and pays monthly CRDP compensation. CRDP is retired pay and payments are taxed.

CRSC is for military retirees with combat-related disabilities of 10% or greater. Combat related determinations are made by the CRSC Board for the branch of service from which the member retired. A combat related determination is made for each VA disability claimed. The retiree must apply using the CRSC application form (DD- 2860 July 2011). The "burden of proof" as to the cause of the disability is on the claimant and the claim must be supported by official documentation to include the DD-214, VA Rating Decisions, applicable service medical records (SMR's), and pertinent service personnel records. Reconsiderations are accepted if new official documentary evidence is provided or for any new disabilities rated by the VA. Appeal authority for CRSC is the Board for Correction of Naval Records (BCNR).

CRSC compensation for medical retirees is calculated by DFAS using a complicated formula that takes into account the PEB, VA and CRSC percentages. CRSC pay cannot exceed what would have been the Years of Service (YOS) retired pay amount, but can be much less and sometimes zero. CRSC pay is a benefit and CRSC payments are not taxed. Medical retirees can go to <a href="http://www.dfas.mil/militarymembers/woundedwarrior/disabledretireest.htm">http://www.dfas.mil/militarymembers/woundedwarrior/disabledretireest.htm</a> to estimate the approximate CRSC pay they will receive.

Claimants may apply for CRSC under one of four categories:

- 1) Direct result of Armed Conflict (AC)
- 2) While engaged in Hazardous Service (HS)
- 3) In the performance of duty under conditions Simulating War (SW)
- 4) Disabilities resulting from the operation of an Instrumentality of War (IN)

# CRDP & CRSC (2019) continued

In order for a CRSC claim to be approved, there must be a direct causal relationship between the armed conflict or training exercise that simulates war and the resulting disability. The CRSC board makes combat related determinations only on VA rated service connected disabilities. Slips, trips, and falls, lifting heavy objects, as well as physical training, are not combat-related disabilities. The fact that a veteran incurred a disability during a period of war or simulated war; or in an area of armed or simulated conflict, or while participating in combat or simulated combat operations; is not sufficient to support a combat-related determination. Only the CRSC Board for each branch of Service is authorized to make combat-related determinations for CRSC. Combat Zone (CZ) notations in VA and PEB documents are not combat related determinations.

A reconsideration request to the CRSC Board is required if your VA rating percentage increases due to the VA approval of a new or unclaimed disability. <a href="http://www.secnav.navy.mil/mra/CORB/documents/CRSC-Navy-Recon-Request-Form-APR-2015.doc">http://www.secnav.navy.mil/mra/CORB/documents/CRSC-Navy-Recon-Request-Form-APR-2015.doc</a>

Retroactive payments are paid for CRSC, but CRSC compensation is subject to the **6-year Barring Statute.** DFAS and/or the VA can authorize back pay/VA Retro back pay, six years from your application, but can go no further back than the VA effective date, age 60 birthdate for reserve retirees, or the CRSC program effective date.

# myPay Advantages of Managing Your Account Online

Did you know you can simplify your life by managing your retired or annuitant pay account online? Using myPay puts a range of information and options for updating your account at your fingertips. And myPay is now simpler, more streamlined, and more mobile-friendly, so it's easier to use on your favorite mobile device.

### What can you do in myPay?

You can update and manage the following account areas:

- Update your mailing address or email address Keep your contact information up-to-date to make sure you don't miss important notifications.
- Change your tax withholding Make sure you have the correct tax withholdings so you don't get surprised at tax time.
- Start, stop, or change a voluntary electronic funds transfer (EFT) allotment (retirees only) Allotments you choose can be managed in myPay.
- Change your direct deposit information Update your bank account information securely and easily online in myPay.
- Add or change your beneficiary for arrears of pay (retirees only) Make sure your beneficiary for your final retired pay payment is up-to-date to avoid delays and extra paperwork.
- Submit your certificate of eligibility (COE) or report of existence (annuitants only) Complete your annual certification.
- You can also use myPay to review your pay statements, conveniently get your tax statements, or to get an official verification of pay letter.

Plus, when you have an email address in myPay, you can receive email notifications about Marine Corps news and events and notifications about your pay account.

Using myPay is faster and more secure than mailing or faxing your changes. For example, if you make a change to your bank account in myPay during the first half of the month, it will generally be effective for the upcoming payday. When you mail or fax a change to us you should plan for 30 days for the change to process. Also, when you use myPay to make a bank account or allotment change, myPay will provide an effective date, so you'll know when the change will be effective.

If you haven't used myPay in a while, you'll see some big differences when you go there. On 4 May 2019, DFAS refreshed myPay, making it simpler and more streamlined to use. The most striking difference is the appearance of the myPay home page, which now looks more like other online financial sites. The login area is now on the right side instead of the left, there is a banner area with important information in the middle, and there are quick links at the topo.

When you log in to your myPay account, you will also see a streamlined navigation menu that appears on the left side of every page. The same menu choices for getting pay and tax statements, and making pay changes are available; the menu is now organized into two categories: statements and pay changes.

The menu options for updating your email address, and changing your login ID and password are now under "Personal Setting" in the menu bar at the top of the page.

Another change is that myPay is now easier to use on a favorite mobile device. When you use myPay on your mobile browser, the menus and screens will adjust to the screen size. The familiar three-bar menu icon gives you options to click to specific areas of the site.

What has not changed is your login ID and password; those transferred over. The same login ID and password you used before the transformation, you can use after (as long as your password did not expire). And the "Forgot your Login ID?" and "Forgot or Need a Password?" options are still available, located under the new login box on the top right.

When you see a myPay homepage that looks different after the changeover, you can ensure you are on the official myPay site by checking your browser's address bar for the correct myPay <u>URL: https://mypay.dfas.mil</u>

DFAS also has video how-to's to help you accomplish a variety of common online tasks, such as accessing a myPay account for the first time, password updates, and bank account and address changes. The tutorial videos are available at YouTube.com/DFAS.

If you're not using myPay to manage your retired or annuitant pay account, now is the time. Head over to myPay to get started: <a href="https://mypay.dfas.mil">https://mypay.dfas.mil</a>.

**Military Retirees:** myPay accounts are established on the 2nd of each month.

You can continue to access myPay using the Login ID and Password established when you were on Active/Reserve duty. Your retired pay account will be visible (in addition to your active/reserve pay account) once it has been established, generally, on the 2nd of the month following your first retired pay paydate.

If you have never established a Login ID / Password, click 'Forgot or Need a Password'. The password will be sent to your mailing address on record with DFAS Retired and Annuitant Pay (R&A Pay). Upon receipt of your temporary password get started at the myPay home page. "Create your myPay Profile" by selecting "Start here." If R&A Pay does not have your current address, please contact R&A Pay at 1-800-321-1080 to update your address before requesting a new temporary password.

**Gray Area Retirees:** A 'Gray Area' retiree is an individual who has met the 20-year reserve qualifying service requirement for entitlement to receive retired pay, pending attainment of the statutory age.

If you are a 'Gray Area' retiree and have reached the statutory age, and do not have a myPay Password, please click "Forgot or Need a Password" on the myPay home page to request one. Upon receipt of your temporary password get started at the myPay home page. "Create your myPay Profile" by selecting "Start here."

If you have not met the statutory age, you will not have a myPay account. If you receive the error message "your payroll is not associated with this service" when trying to access myPay, this indicates that your retired pay account has not yet been established. New accounts are established in myPay on the 2nd of each month following your first payday. If you feel that your retired pay account should be established, please contact Retired & Annuitant Pay at 1-800-321-1080.


### **2020 SECNAV RETIREE COUNCIL VACANCY**

### 2019 Retired & Annuity Pay Dates



To help you plan for 2019, below is a list of the days you should expect to receive your retired or annuitant pay. Retired and annuitant pay is disbursed on the first of the month. However, if the first falls on a weekend or holiday, retirees get paid on last business day of the prior month and annuitants get paid on the first business day of current or prior month. Please see the chart for each month in 2019.

Tricare considers retirement a qualifying life event (QLE), and one that may have a new retiree reconsidering their family's health care coverage.

Effective immediately, retiring service members, now have up to a year (365 days) vice the previous 90 day period allotted QLEs to decide whether to stay with Tricare Prime or choose Tricare Select. This change provides more time for the services to update the retiree's status in the Defense Enrollment Eligibility Reporting System (DEERS).

As an active duty service member, health coverage in Tricare Prime doesn't expire until the retiree hits their actual retirement date. Once retired they are able to choose and enroll in either Tricare Prime or Tricare Select, but the decision must be made within 365 days of retirement. Coverage is retroactive to the date of retirement. During the 365 day eligibility period, while the member is considering a health care plan, they are eligible to be seen at a military treatment facility.

If the member fails to enroll within the 365 day eligibility period, the member will lose Tricare coverage and will not be able to enroll in Tricare until another qualifying life event or open season.

### Veterans of the Korean War Eligible for Revisit Korea Program

In 1975, the Republic of Korea's (ROK) government began the *Revisit Korea Program* as a means of expressing its appreciation to all United Nations veterans of the Korean War and their family members. The ROK government appropriates funds for this special program, and the Ministry of Patriots and Veterans Affairs (MPVA) in Seoul administers it. If interested Korean War veterans are required to make their own airline reservations (assisted by the staff of Military Historical Tours) and pay their airfare. The veterans are reimbursed 50 percent of their flights costs and companions 30 percent. The MPVA funding covers all ground transportation within Korea, lodging, and meals.

Four trips are being offered in 2019: July 22-28; Sep 25-Oct 1; Oct 20-26; and Nov 8-14. \*Note: 2020 will be the last year for the Korea Revisit Program for combat veterans who served in Korea during the war. - Have a service-connected disability incurred in the line of duty in the Armed Forces.
- Served in a war theater during a time of war declared by Congress or were eligible for hostile fire special pay and are suffering from injuries, disease or disability.

Those who served in a women's component of the Armed Forces before June 12, 1948 and are determined to be eligible for admission because of compelling personal circumstances will also be considered.

Married couples who meet eligibility requirements above are welcome, as are non-military spouses of career-retired applicants. Please call us for details!

Veterans who have been convicted of a felony or are not free of drug, alcohol, or psychiatric problems are ineligible to become a resident. ### **Keeping Your Uniformed Services ID Card Secure**

You are responsible for keeping your ID card in good condition, and you are the only person allowed to use the card. Any person willfully altering, damaging, lending, counterfeiting, or using these cards in an unauthorized manner is subject to fines or imprisonment or both. Using an ID card to obtain benefits and privileges to which a person is not entitled to is considered fraudulent and is unauthorized. Examples of authorized photocopying include photocopying of DoD ID cards to facilitate medical care processing, check cashing, voting, tax matters, compliance with appendix 501 of title 50, U.S.C. (also known as "The Servicemember's Civil Relief Act"), or administering other military-related benefits to eligible beneficiaries.

### **Updating Information on Your ID Card**

Updating information on your card starts with updating information in DEERS. Once you are registered in DEERS, you are responsible for keeping your DEERS records updated when your personal eligibility information changes. This includes changes in military career status, addresses, and family status (marriage, divorce, birth, and adoption).

To update DEERS information, you may call the Defense Manpower Data Center Support Office (DSO) Telephone Center at 1-800-538-9552 or for the Deaf (TTY/TDD): 1-866-363-2883, Monday through Friday, 6:00 a.m. to 3:30 p.m. Pacific Time, except federal holidays.



# Your Military Identification Card

# Two Forms of Identification Are Now Required:

To replace or renew your military ID card, two forms of identification are required:

- 1. **A VALID PHOTO ID** Acceptable photo identification includes a driver's license, valid military ID card, valid passport or permanent resident alien card. <u>All photo IDs must be current; expired photo IDs are not accepted.</u>
- 2. **A SECONDARY ID.** A secondary ID may include one of the photo IDs listed above or a Social Security card (not a Medicare card), a voter registration card, birth certificate, or student ID if you are a college student. To avoid delays, call your nearest ID card center for hours of operation and availability.

# Military ID Cards for Family Members:

Indefinite military ID cards are now issued to eligible family members who are 75 or older.

The 2007 National Defense Authorization Act authorized the issuance of indefinite military ID cards for incapacitated dependent children over 21. To qualify for an indefinite ID card, a determination of permanent incapacitation must be made by the Bureau of Medicine and Surgery and a current financial dependency determination (over 50%) is required. A financial redetermination will also be required every four years.

**Dependent wards, parents and parents-in-law,** including those over 75 with permanent military ID cards will also require a financial redetermination every four years.

**Full-time students over 21,** may be eligible for military ID card benefits until 23 provided they are enrolled full-time in a college or university and are dependent on the member for over 50% of their financial support. It is the service member's responsibility to ensure eligible family members are updated in DEERS and to notify DEERS of any changes in eligibility. For more information, call MMSR-6 at 1-800-336-4649 or (703) 784-9310.

# The Retired Marine's Military ID Card:

When a military service member retires, the ID card issued will have an expiration date on the front and back, coinciding with his/her 65th birthday. ID cards will be replaced if they are lost, stolen, or damaged; they will also be replaced for a name change due to marriage, divorce, or to replace an older version of the ID card. If applicable, divorce decrees and/or marriage certificates may be required. A retired member's ID card must also be replaced when turning 65 and enrolling in Medicare Part B. With Medicare Part B enrollment, a retired Marine is automatically enrolled in TRICARE for Life, which will require updating the medical eligibility dates on the back of the ID card. If the dates on the back of your ID card have expired, replace the ID card (and have the Medicare Part B card with you when updating the military ID card).

# Eligibility for a Military ID Card By Mail:

If you are requesting to have a military identification card by mail, you must have a notary's signature on the back of the photograph. According to Air Force Instruction 36-3026 (17 June 2009):

PORTRAIT-STYLE PHOTOGRAPHS, 8X10 OR 5X7, REQUIRE SIGNATURE NOTARIZATION ON THE BACK AND INCLUDE WEIGHT, HEIGHT, EYE COLOR, AND HAIR COLOR.

You must live more than 300 miles from a military ID card center. Include a statement why you are unable to travel to an ID card center. 

# Steps to Take When an Annuitant Dies

# ELIGIBILITY FOR SURVIVOR BENEFIT PLAN ANNUITY PAY ENDS WITH THE DEATH OF THE ANNUITANT (BENEFICIARY)

Prompt reporting of a deceased military annuitant's death can help avoid delay and prevent possible financial hardship for the surviving family members or executors, who will be required to return any unearned payments of the decedent's annuity pay if payment is erroneously received. \*\*\*While the VA does not provide burial benefits for annuitants, the annuitant may be eligible for burial in a military cemetery.

Follow these steps to report the death of an annuitant:

- 1. Call DFAS at 1-800-321-1080 to report the death and stop annuity pay.
- 2. Mail or fax a copy of the annuitant's death certificate to:

- 3. Inform any financial institutions receiving payments about the death of the annuitant. (Provide a copy of the death certificate when it becomes available).
- 4. If applicable, contact the following agencies/departments immediately to report the death:
- Social Security Administration: 1-800-772-1213 www.ssa.gov
- Defense Enrollment Eligibility Reporting System: 1-800-538-9552

If you believe you are the victim of an error or injustice which affects your military record, you may apply for a Correction of Military Records by completing and submitting a DD Form 149, Application for Correction of Military Record. Examples of corrections include: upgraded discharge, promotions, retired pay, household goods, pay date change, bonus, and MGIB programs. DFAS pays military members when the Board for Corrections of Naval Records (BCNR) rule in their favor. If you received a decision from the BCNR and you do not agree with it, write the Board and explain your reasoning. Reference the appropriate address on page 2 of the DD Form 149. If you would like to check the status of your request contact the BCNR directly at (703) 604-6884 or 6885 (Navy/Marine Corps). If you believe DFAS paid you incorrectly for your Correction of Record, provide documentation with a handwritten signature explaining why you are protesting the amount to:

## Steps to Take When a Retired Marine Dies

1. REPORT THE DEATH TO DFAS at 1-888-332-7411 to stop retirement pay to avoid indebtedness. If the retired Marine was receiving pay from another source due to a disability from the VA or civil service retirement from the Office of Personnel Management, contact that agency to return the payment. If you fail to do this, you will have to repay it later.

You may also report the death online at <a href="www.dfas.mil/retiredmilitary/forms.html">www.dfas.mil/retiredmilitary/forms.html</a>. Additional information from DFAS is available at <a href="www.dfas.mil/retiredmilitary/survivors/Retiree-death.html">www.dfas.mil/retiredmilitary/survivors/Retiree-death.html</a>.

For families located overseas, the commercial number is **216-522-5955**, select option 3 to be directed to the appropriate representative.

NOTE: DFAS will forward a confirmed death listing to Headquarters, U.S. Marine Corps (MMSR-6) for inclusion in an upcoming issue of this newsletter under the Taps column.

- 2. Within 7-10 business days after reporting the death to DFAS, you should receive a letter containing the following documents:
  - a. SF1174 Claim for Unpaid Compensation of Deceased Member of the Uniformed Service
  - b. Annuity account forms and instructions (if the decedent was enrolled in the Survivor Benefit Plan or the Retired Serviceman's Family Protection Plan)
  - c. W-4P Withholding Certificate for Pension or Annuity Payments
  - d. Direct Deposit form

Complete the forms you received with your letter and return them with a copy of the retiree's Death Certificate that includes cause of death to:

- 3. REPORT SURVIVOR BENEFIT PLAN ELECTION, *if applicable*. Designated annuitants will receive notification from DFAS if the deceased retired Marine elected SBP. If you are uncertain whether an election was made, call DFAS at 1-800-321-1080.
- 4. UPDATE YOUR MILITARY ID CARD. Your status has changed, and as the survivor of a deceased Marine, your ID card must be updated to reflect it due to the Marine's death. Access your nearest ID site at <a href="www.dmdc.osd.mil/rsl">www.dmdc.osd.mil/rsl</a> or call HQMC (MMSR-6) at 1-800-336-4649 or (703) 784-9310 to obtain the sites closest to you.
- 5. NOTIFY THE SOCIAL SECURITY ADMINISTRATION at 1-800-SSA-1213 (<u>www.ssa.gov</u>) to apply for the \$255 death benefit, *if applicable*.
- 6. CONTACT THE VA at 1-800-827-1000 FOR BURIAL AND OTHER VA BENEFITS, such as VA disability payments. Acopy of the sponsor's DD 214 is required. Visit <a href="https://www.va.gov">www.va.gov</a> for more information.
- 7. CONTACT THE U.S. OFFICE OF PERSONNEL MANAGEMENT at 1-888-767-6738 if the sponsor was receiving civil service pay.

# MILITARY FUNERAL HONORS FOR BURIALS OUTSIDE ARLINGTON NATIONAL CEMETERY (ANC)

The funeral director (preferred) or a family member can contact the HQMC Military Funeral Honors Section at (866) 826-3628 or (703) 432-9524 to request Military Funeral Honors for a veteran. The funeral director (or family member) must be able to provide the Marine's complete name, SSN, rank, status (retired or veteran), date of birth, date of death, and place of death/interment. In addition, a copy of the Marine's DD-214 needs to be provided for verification of "honorable service". If a DD-214 is not readily available, it can be requested through the National Personnel Records Center in St. Louis, MO. The following link provides additional details:


