COVID-19 Pandemic/Defense Health Agency/Telehealth/Tricare

Innovations to telehealth are essential to patient care during the COVID-19 pandemic. The Military Health System recognizes the importance of telehealth to prevent in-person spread of the novel coronavirus while still providing quality care to beneficiaries. As a result, the Defense Health Agency is making three temporary revisions to TRICARE regulations regarding telehealth with unprecedented speed.

DHA published an interim final rule in the Federal Register May 12, 2020. The rule invoked temporary changes to how beneficiaries and providers receive and provide telehealth care. These changes to the TRICARE telehealth rules were not Congress-directed.

Changes to regulation that require publication to the Federal Register usually take six months to a year to implement. However, DHA sought to expedite the process due to the urgency to continue providing care during the pandemic. DHA recognizes that both beneficiaries and providers may have technical and capacity limitations to the expansive telehealth demand created by both social distancing recommendations and restrictions to person-to-person interactions.

The agency hopes to implement changes to beneficiaries worldwide in 30-90 days. Once implemented, changes made through the interim final rule will stand as long as the country remains in a state of national emergency, as declared by the president on March 13, 2020.

- Change one: Beneficiaries will be given access to audio-only telephone visits with their providers. TRI-CARE will permit audio-only health care visits to improve access to care for beneficiaries that cannot access audio-visual care. Beneficiaries that cannot access audio-visual care due to lack of in-home technology, such as smartphones or computers, or who live in remote areas without the bandwidth for video conferencing, can take advantage of this service.
- Change two: TRICARE will reimburse providers that practice interstate telehealth where permitted by federal or state law, even if the provider is not licensed in the state where they are remoting in. Usually, providers that offer telehealth must be licensed in both the state where they practice and the state where their beneficiaries reside. This requirement will be temporarily modified to allow providers to expand their telehealth reach and still qualify for reimbursement. The rule also applies to providers overseas as long as a provider holds an equivalent license in another nation, and the host nation permits such practice.
- Change three: Temporarily waives cost-shares and copayments for covered, in-network telehealth services. This change doesn't cover just services related to COVID-19, but all telehealth services inside of the network. DHA hopes that by removing these costs, beneficiaries take advantage of telehealth and reduce exposure of others to TRICARE beneficiaries who may have the novel coronavirus.

Although the new rules are effective May 12, it will take time for all of the changes to be fully implemented. Beneficiaries may still be assessed a copay for telehealth services over the next few months, but adjudicated claims will either be pending or copays may be reimbursed. Some changes may remain in effect beyond the national emergency for overseas locations. DHA will reevaluate telehealth changes in the long term once the threat of COVID-19 diminishes.

Future updates will be posted to <u>Health.mil</u> and <u>TRICARE.mil</u> as they are finalized.

FRAUD ALERT

COVID-19 Test Scam Messages

The U.S. Department of Health and Human Services Office of Inspector General is alerting the public about fraud schemes related to the novel coronavirus (COVID-19).

Scammers are offering COVID-19 tests to Medicare beneficiaries in exchange for personal details, including Medicare information. **However, the services are unapproved and illegitimate.**

Fraudsters are targeting beneficiaries in a number of ways, including telemarketing calls, text messages, social media platforms, and door-to-door visits.

These scammers use the coronavirus pandemic to benefit themselves, and beneficiaries face potential harm. The personal information collected can be used to fraudulently bill Federal health care programs and commit medical identity theft. If Medicare or Medicaid denies the claim for an unapproved test, the beneficiary could be responsible for the cost.

Protect Yourself

- Beneficiaries should be cautious of unsolicited requests for their Medicare or Medicaid numbers.
- Be suspicious of any unexpected calls or visitors offering COVID-19 tests or supplies. If your personal information is compromised, it may be used in other fraud schemes.
- Do not respond to, or open hyperlinks in text messages about COVID-19 from unknown individuals.
- Ignore offers or advertisements for COVID-19 testing or treatments on social media sites.
- A physician or other trusted healthcare provider should assess your condition and approve any requests for COVID-19 testing.

Express Scripts

Offers Several Options For Filling Your Prescriptions

Military Pharmacies

Military pharmacies are the least expensive option for filling prescriptions.

- At a military pharmacy, you may receive up to a 90-day supply of most medications at no cost.
- Most military pharmacies accept prescriptions written by both civilian and military providers, regardless of whether or not you are enrolled at the military hospital or clinic.
- Non-formulary medications are generally not available at military pharmacies. To check the availability of a drug contact the nearest military pharmacy.

TRICARE Pharmacy Home Delivery

- TRICARE Pharmacy Home Delivery is your least expensive option when not using a military pharmacy.
- Receive up to a 90-day supply of generic formulary medications at low cost, however copayments apply for brand-name and non-formulary medications (up to a 90-day supply).
- Additionally, prescriptions are delivered to you with free standard shipping, and refills can be easily ordered online, by phone, or by mail.

TRICARE Retail Network Pharmacies

 This option allows you to fill your prescriptions at TRICARE retail network pharmacies throughout the country without having to submit a claim.

Non-Network Pharmacies

When visiting non-network pharmacies, you pay
the full price of your medication up front and file
a claim to Express Scripts for reimbursement.
Reimbursements are subject to deductibles, outof-network cost-shares, and TRICARE-required
copayments. All deductibles must be met before
any reimbursement can be made.

You can manage your medication from anywhere with the free Express Scripts app. It's like having a pharmacy in your phone. The app is built for iPhone® and AndroidTM devices and offers a free, safe, and convenient way to manage your medications.

Search Express Scripts in your app store, download the app, and log in with your Express Scripts username and password.

The Express Scripts app makes it simple to:

- Order Refills: Quickly order your medications. If your order is ever canceled, Express Scripts will send you a message explaining what happened. They will also contact you if you need a new prescription.
- See Order Status: Track your order in realtime. You can also cancel an order if it hasn't processed yet.
- Set Automatic Refills: Set up automatic refills for your medication. Express Scripts will ship it to you before you need it. Once a year, they will ask you to confirm you still want automatic refills. You don't need to do anything else to get your medication.
- Set Dose Reminders: Set up alerts to remind you to take your medication. You can set daily, weekly, or monthly reminders. Your drug history automatically updates in the app. And, it checks for drug interactions that could be harmful to you.

Survivor Benefit Plan School Certifications Now Easier and More Convenient

Military Survivor Benefit Plan (SBP) recipients between 18 and 22 years old who must certify their status as a full-time student will benefit from sweeping changes the Department of Defense and the Defense Finance and Accounting Service (DFAS) made to simplify the process and the form.

School

Certification

College students now certify annually instead of each term, students no longer need a school official signature or school documentation when they certify, and the school certification form is shorter and simpler. The changes will significantly reduce the paperwork burden and make the process easier and more convenient for full-time student child annuitants.

The Survivor Benefit Plan provides an ongoing monthly annuity payment to military spouses or children when a military member dies while on active duty, on inactive duty, or after retirement (if the retiree chooses to purchase coverage).

The plan's payments to child annuitants typically end when they reach age 18. However, if the child annuitant attends school full-time - in high school or at an accredited trade school, technical or vocational institute, college or university - they are eligible to continue receiving payments until the end of the school year during which they turn 22, as long as they remain unmarried.

To continue the annuity payments, a child annuitant over 18 must regularly certify they are a full-time student.

The significant changes to the process include:

- College student annuitants only need to certify their full-time attendance once a year during the summer, instead of each term, significantly cutting the paperwork burden.
- Student annuitants self-certify their attendance without the need for a school official signature or documentation from the school, making it quicker and easier for students.
- The school certification form is shorter and simpler, focusing on the student annuitant's future schooling plans. For certifying past attendance, DFAS will mail student annuitants a letter with pre-filled information for them to sign.
- Students can upload a PDF of their signed and dated school certification form and letter online on the DFAS website, which is mobile-friendly. The online upload tool is at: https://go.usa.gov/xymaH
- If students provide an email address in myPay, the DFAS pay management portal, DFAS will send an email reminder when they have a school certification coming due.

Arrears of Pay Direct Deposit Now Available

Arrears of Pay (AOP) is a one-time payment made to a beneficiary after your death. The arrears of pay payment to a beneficiary will include the pro-rated amount of your final month's pay, and any other money owed at the time of your death. Your entitlement to retirement pay ends on the date of your death. When your death is reported, DFAS will reclaim your final month's pay and audit your account. The amount of the payment actually owed to you will then be computed and given to your AOP Beneficiary. DFAS can deposit an AOP payment directly to an eligible claimant's bank account instead of mailing a check reducing the time it takes to receive the payment.

To have an AOP payment direct deposited to their bank account, the claimant needs to send a completed Direct Deposit Authorization (DFAS-CL Form 1059) with their SF 1174. This form and instructions are available for download from the webpage:

Have You Done Your Retired Pay Account Checkup?

It's important to regularly review and update your retired pay account. Keeping your account current will ensure that DFAS can get in touch with you if there is information you need to know about your retired pay and help make sure that outdated information doesn't cause difficulties for you or your loved ones down the road.

Use this handy roadmap to perform a retired pay checkup at least once a year.

1. Is your mailing address current?

- You might be surprised to learn DFAS gets a lot of returned mail. If you've moved and haven't told us, we won't know how to reach you. Let's keep the lines of communication open!
- Log in to your myPay account and check your "Correspondence Address" under "Pay Changes" on the side menu as part of your annual account check-up: https://mypay.dfas.mil

2. Do you have a current email address in myPay?

- Make sure you have an email address in myPay and that it is current. Email is the easiest and fastest way to communicate with you. If we have your email address, you will hear news faster. Take a minute right now and check to make sure your email address is current. At the top of your myPay account menu, select "Personal Settings" and then in the side menu on the left, select "Email Address" to view the email address(es) you have on file with DFAS. Make sure you indicate the primary email address you want us to use, and check the box to indicate if the address is still valid. Delete any old email addresses you no longer use.
- While you are in myPay, add a mobile phone number (domestic numbers only) so you can receive key myPay account notifications via text.

3. Are your allotments correct?

- Review your allotments at least once a year. Look under "Pay Changes" for "Allotments" in the menu on the left side of your myPay account. Check each allotment and the allotment amounts. Make sure each allotment is current and the amount is correct.
- Please keep in mind that some allotments cannot be changed using myPay. Some of the common allotments that cannot be changed using myPay include FEDVIP, Tricare, and NSGLI. If you have a question about any allotments that you cannot change on myPay, please contact that company or organization directly.

4. Have there been changes in your family?

- If you get married, lose a spouse, or have a child, the change can affect your Survivor Benefit Plan information.
- If there have been any changes in your family, please send DFAS a copy of the official documentation (marriage license, divorce decree, death certificate, or birth certificate), as well as a request for how you want us to update your account.
- ♦ Always notify DFAS as soon as possible about a major life change. You can fax your documents to 1-800-469-6559 or mail them to DFAS, 8899 E 56th Street, Indianapolis, IN 46249-1200. Make sure your Social Security Number is clearly visible on each document so we can identify your account to update it.

5. Is your Arrears of Pay beneficiary correct?

• Who did you choose as a beneficiary for any arrears of retired pay that may be due when you pass away? Make sure your designation is current and confirm that your beneficiary's address is up to date.

- You can check this information by clicking on the "Beneficiary for Arrears" link under "Pay Changes" in the menu on the left side of your account in myPay.
- You can make changes to your designation and update address information through myPay.

6. Are your Survivor Benefit Plan (SBP) coverage and beneficiary(ies) correct?

• Your Retiree Account Statement (RAS), available in myPay, has a lot of information on it about your pay, deductions, taxes, and SBP. The SBP section has five lines on it for members who participate in SBP. The most important for you to check: your type of coverage, and date of birth of your spouse beneficiary (if applicable).

Set a yearly reminder to look over your information to make sure your account is up to date. So, pick a date! It doesn't matter if it's your retirement anniversary date, your birthday, or the first of the year.

INTRODUCING RAPIDS ID CARD OFFICE ONLINE

Previously called the Rapids Self Service (RSS), the first deployment of the **ID Card Office Online** production is easy-to-navigate and a welcome change.

Visit https://idco.dmdc.osd.mil/idco to update your Common Access Card (CAC), manage sponsor or family member ID card information, or find the location of your nearest RAPIDS ID Card Office.

The Site Locator and Appointments User Guide is accessible under "Help" and will be updated with every release.

- This is a single site for users to locate sites, schedule appointments, and determine walk-in hours.
- It provides the ability to search by location, a date range, and a time range for appointments and walkins.
- Sites will not be displayed if appointments are not available (when searching for appointments).
- Sites will not be displayed if walk-in hours are not available (when searching for walk-ins).
- Reminder email notifications are sent 1 and 3 days prior to scheduled appointments.
- Locations matching search criteria are displayed on Google Maps with zooming capabilities.

Utilize the "Feedback" screen to share desired enhancements, issues, or general feedback.

DoD Response to COVID-19 - DoD ID Cards and Benefits



The Department of Defense is committed to protecting the security of our nation and its people by issuing identification (ID) cards to individuals requiring access to government systems and facilities, and to eligible individuals authorized to receive Uniformed Service benefits and privileges by law.

The Department is equally committed to the safety of our personnel and beneficiaries, including retirees and other high-risk populations. This includes ensuring continued access to healthcare and other benefits during this time of increasing precaution and restrictions in response to the Coronavirus (COVID-19).

To ensure DoD ID card offices are postured to maintain continuity of operations, and to minimize the number of non-essential required visits at DoD ID card offices, the following guidance is in effect through September 30, 2020:

Uniformed Services ID Cards (USID)

- If a cardholder's affiliation is unchanged, USID cards which expired on or after January 1, 2020, are authorized for continued benefit use through September 30, 2020.
- Termination of cardholder affiliation with the DoD or termination of benefit eligibility shall be verified electronically prior to confiscating an expired USID card with an expiration date on or after January 1, 2020.
- Remote USID card renewals and reissuance shall be expanded.
- Remote family member enrollment/eligibility updates are authorized.
- Remote USID card initial issuance for first-time issuance or replacement of lost/stolen ID card is authorized.
- All remotely-issued USID cards shall be issued with an expiration date not to exceed one year from the date of issuance.
- The minimum age for initial USID card issuance is increased from 10 to 14 years.
- Continued use of the Reserve USID card to obtain active duty benefits is authorized for mobilized Reservists and their eligible dependents.

The Defense Enrollment Eligibility Reporting System (DEERS) will continue to be the authoritative source to verify statutory eligibility for DoD Healthcare and other benefits.

POPULATIONS REQUIRING FIRST TIME ENROLLMENT AND ID CARD ISSUANCE



For individuals unable to access a RAPIDS site due to closures and/or limited services, the Marine Corps DEERS Project Office will remotely process new Enrollments ONLY.

Individuals enrolled in this manner will have 90 days to provide original documents to Verifying Officials (VO) at the RAPIDS site once normal site operations resume.

Required documents should be emailed (preferred) to both <u>mary.stroz@usmc.mil</u> and <u>donna.rodgers@usmc.mil</u> or faxed to (703) 432-2591.

Requests for enrollments can take up to 10 business days to be processed from time of receipt.

1: My DoD ID card has expired or is expiring soon; what do I do?

Through September 30, 2020, DoD will temporarily allow some cardholders to use an expired DoD ID card to access bases and benefits.

Uniformed Services ID Cards

Uniformed Services ID (USID) cards that expire on/after January 1, 2020 may continue to be used to access military bases and benefits. In order to use the expired USID card, the cardholder must have a current affiliation with DoD and must be eligible for benefits.

For example:

- ☐ An ID card issued to a spouse typically expires every four years; however, as long as the spouse remains married to the Service member, the spouse continues to have a current affiliation and is eligible for benefits.

 o As a result, a spouse MAY use the expired DoD ID card to access benefits.
- ☐ An ID card issued to a child of a Service member expires when the child turns 21 years old. Unless attending school as a full-time student, approved as an incapacitated dependent, or enrolled in TRICARE Young Adult, the child's affiliation ends when the ID card expires and is not eligible for continued benefits.
- o As a result, a child who has turned 21 and is not eligible for continued benefits MAY NOT use the expired DoD ID card to access benefits.

NOTE: A child under age 21, or who is eligible for continued benefits, MAY use the expired DoD ID card to access benefits.

QUESTION 2: I need to enroll a new family member; what do I do?

Through September 30, 2020, DoD will temporarily allow new family members to be enrolled by mail or fax. Family members over age 14 will also be eligible for DoD ID card issuance by mail. All ID cards will be issued for up to 1 year, and original documents must be provided to a DoD ID card issuance facility before the card expires in order for the cardholder to remain eligible for benefits.

QUESTION 3: I need to update my status; what do I do?

Through September 30, 2020, DoD will temporarily allow updates by mail or fax. This includes updates such as enrolling a child turning age 21 as either a full-time student or an incapacitated dependent. Updates to personnel segments, such as the status of a Service member, civilian, or contractor, will continue to be provided by the authoritative systems, like MilPDS, DCPDS, and TASS.

QUESTION 4: Is my local ID card issuing facility open?

You can find your nearest ID card issuing facility and schedule appointments at https://idco.dmdc.osd.mil/idco. Some sites are only allowing appointments and increasing the time between customers to support social distancing measures. DoD ID card issuing facilities are keeping their hours and availability up to date on this resource, as well as local phone lines and websites.

QUESTION 5: My local ID card issuing facility is closed; what do I do?

Common Access Cards Transactions related to the CAC typically must be performed in person, including PIN resets and renewal/reissuance. Please visit ID Card Office Online at https://idco.dmdc.osd.mil/ idco to find your nearest ID card issuing facility and schedule an appointment.

Uniformed Services ID Cards Please see questions 1-3 about alternatives to visiting a DoD ID card issuing facility in person. If you have a question not addressed by these FAQs, please contact the Defense Human Resources Activity (DHRA) at dhracacpolicy@mail.mil.



2020 Retired & Annuity Pay Dates



To help you plan for 2020, below is a list of the days you should expect to receive your retired or annuitant pay. Retired and annuitant pay is due on the first of the month. However, if the first falls on a weekend or holiday, retirees get paid on the last business day of the prior month and annuitants get paid on the first business day of month. For example, payment to retirees for December 2019 were paid on December 31, 2019. However, annuitants were paid on January 2, 2020. Please see the chart for each month in 2020.

RETIREES AND ANNUITANTS ARE ADVISED TO CHECK THEIR PERSONALLY IDENTIFIABLE INFORMATION FOR CORRECTNESS REGULARLY.

Q: How does a Retiree correct their date of birth or name in DEERS?

A: Please send a copy of your birth certificate to the MMSR-6 organizational mailbox: smb.manpower.mmsr6@usmc.mil or by regular mail to:

MMSR-6 will notify DFAS Cleveland Center once your Service record has been corrected. It takes DFAS about 60-90 days to make their corrections. June is PTSD Awareness Month.

PTSD (post-traumatic stress disorder) is a mental health problem that some people develop after experiencing or witnessing a life-threatening event, like combat, a natural disaster, a car accident, or sexual assault.

It's normal to have upsetting memories, feel on edge, or have trouble sleeping after a traumatic event. At first, it may be hard to do normal daily activities, like go to work, go to school, or spend time with people you care about. But most people start to feel better after a few weeks or months.

If it's been longer than a few months and you're still having symptoms, you may have PTSD. For some people, PTSD symptoms may start later, or they may come and go over time.

- Even though PTSD treatments work, most people who have PTSD don't get the help they need.
- Everyone with PTSD—whether they are Veterans or civilian survivors of sexual assault, serious accidents, natural disasters, or other traumatic events—needs to know that treatments really do work and can lead to a better quality of life.

Steps to Take When an Annuitant Dies

ELIGIBILITY FOR SURVIVOR BENEFIT PLAN ANNUITY PAY ENDS WITH THE DEATH OF THE ANNUITANT (BENEFICIARY)

Prompt reporting of a deceased military annuitant's death can help avoid delay and prevent possible financial hardship for the surviving family members or executors, who will be required to return any unearned payments of the decedent's annuity pay if payment is erroneously received. ***While the VA does not provide burial benefits for annuitants, the annuitant may be eligible for burial in a military cemetery.

Follow these steps to report the death of an annuitant:

- 1. Call DFAS at 1-800-321-1080 to report the death and stop annuity pay.
- 2. Mail or fax a copy of the annuitant's death certificate to:



- 3. Inform any financial institutions receiving payments about the death of the annuitant. (Provide a copy of the death certificate when it becomes available).
- 4. If applicable, contact the following agencies/departments immediately to report the death:
- Social Security Administration: 1-800-772-1213 www.ssa.gov
- **Defense Enrollment Eligibility Reporting System:** 1-800-538-9552

If you believe you are the victim of an error or injustice which affects your military record, you may apply for a Correction of Military Records by completing and submitting a DD Form 149, Application for Correction of Military Record. Examples of corrections include: upgraded discharge, promotions, retired pay, household goods, pay date change, bonus, and MGIB programs. DFAS pays military members when the Board for Corrections of Naval Records (BCNR) rule in their favor. If you received a decision from the BCNR and you do not agree with it, write the Board and explain your reasoning. Reference the appropriate address on page 2 of the DD Form 149. If you would like to check the status of your request contact the BCNR directly at (703) 604 - 6884 (Navy/Marine Corps). If you believe DFAS paid you incorrectly for your Correction of Record, provide documentation with a handwritten signature explaining why you are protesting the amount to:

Steps to Take When a Retired Marine Dies

1. REPORT THE DEATH TO DFAS at 1-888-332-7411 to stop retirement pay and avoid indebtedness. If the retired Marine was receiving pay from another source due to a disability from the VA or civil service retirement from the Office of Personnel Management, contact that agency to return the payment. If you fail to do this, you will have to repay it later.

You may also report the death online at www.dfas.mil/retiredmilitary/forms.html. Additional information from DFAS is available at www.dfas.mil/retiredmilitary/survivors/Retiree-death.html.

For families located overseas, the commercial number is **216-522-5955**, select option 3 to be directed to the appropriate representative.

NOTE: DFAS will forward a confirmed death listing to Headquarters, U.S. Marine Corps (MMSR-6) for inclusion in an upcoming issue of this newsletter under the Taps column.

- 2. Within 7-10 business days after reporting the death to DFAS, you should receive a letter containing the following documents:
 - a. SF1174 Claim for Unpaid Compensation of Deceased Member of the Uniformed Service
 - b. Annuity account forms and instructions (if the decedent was enrolled in the Survivor Benefit Plan or the Retired Serviceman's Family Protection Plan)
 - c. W-4P Withholding Certificate for Pension or Annuity Payments
 - d. Direct Deposit form

Complete the forms you received with your letter and return them with a copy of the retiree's death certificate that includes cause of death to:

- 3. REPORT SURVIVOR BENEFIT PLAN ELECTION, *if applicable*. Designated annuitants will receive notification from DFAS if the deceased retired Marine elected SBP. If you are uncertain whether an election was made, call DFAS at 1-800-321-1080.
- 4. UPDATE YOUR MILITARY ID CARD. Your status has changed, and as the survivor of a deceased Marine, your ID card must be updated to reflect it due to the Marine's death. Access your nearest ID site at https://idco.dmdc.osd.mil/idco or call HQMC (MMSR-6) at 1-800-336-4649 or (703) 784-9310 to obtain the sites closest to you.
- 5. NOTIFY THE SOCIAL SECURITY ADMINISTRATION at 1-800-SSA-1213 (<u>www.ssa.gov</u>) to apply for the \$255 death benefit, *if applicable*.
- 6. CONTACT THE VA at 1-800-827-1000 FOR BURIAL AND OTHER VA BENEFITS, such as VA disability payments. Acopy of the sponsor's DD 214 is required. Visit www.va.gov for more information.
- 7. CONTACT THE U.S. OFFICE OF PERSONNEL MANAGEMENT at 1-888-767-6738 if the sponsor was receiving civil service pay.

MILITARY FUNERAL HONORS FOR BURIALS OUTSIDE ARLINGTON NATIONAL CEMETERY (ANC)

The funeral director (preferred) or a family member can contact the HQMC Military Funeral Honors Section at (866) 826-3628 or (703) 432-9524 to request Military Funeral Honors for a veteran. The funeral director (or family member) must be able to provide the Marine's complete name, SSN, rank, status (retired or veteran), date of birth, date of death, and place of death/interment. In addition, a copy of the Marine's DD-214 needs to be provided for verification of "honorable service". If a DD-214 is not readily available, it can be requested through the National Personnel Records Center in St. Louis, MO. The following link provides additional details:


SOME THINGS YOU WILL NEED TO DO:

- Review survivor's own legal documents for possible revision
- Obtain multiple certified death certificates (6-12 copies)
