When the company attack had been halted by heavy enemy machine-gun and mortar fire, Private First Class Tedrow moved forward to a position from which he observed an active enemy emplacement Armed with his light machine-gun, he advanced across the open terrain and, firing his weapon as he went, pinned down the enemy in the emplacement until he could direct accurate fire into it. Setting up his machine-qun, he fired the rest of his ammunition through an embrasure in the emplacement, thereby neutralizing this position and aiding his company in continuing its advance. His aggressive fighting spirit and devotion to duty were in keeping with the highest traditions of the United States Naval Service."



Confronted by the enemy's solid, coordinated system of defenses shortly after hitting the beach in the initial landing wave, First Lieutenant Tucker boldly led his unit in a frontal assault against strong fortifications, delivering concentrated mortar, machine-gun and artillery fire in the beach area and, charging four pillboxes and an almost impregnable blockhouse with fierce aggressiveness, succeeded in destroying all five of the enemy strong points as he advanced 300 yards across the beach. With his platoon reduced to one-third its original strength when he discovered that his company commander had become isolated with the remnants of another platoon and was lying seriously wounded under intense enemy fire approximately 400 yards to the left, he unhesitatingly led the remainder of his squad in a second assault, repeatedly exposing himself to the merciless blasts of deadly gunfire as he smashed through the surrounding pillboxes and reached the besieged group. Again risking his life to direct the last of his men into a position of comparative safety, he was fatally struck by a burst of shrapnel and collapsed where he stood. An able and inspiring leader, First Lieutenant Tucker, by his daring tactics, cool decision and dauntless courage in the face of overwhelming odds, aided materially in the reestablishment of his company. His valiant devotion to duty during this critical phase of the action was in keeping with the highest traditions of the United States Naval Service. He gallantly gave his life for his country."





The first to volunteer for an eight man patrol whose dangerous mission was to fight its way to the top of a commanding hill in the vicinity of Bloody Mose ridge on 19 September, he annihilated five energ snipers while scouting for the patrol and knocked out two hostile caves in which resistance was encountered. Although seriously wounded when the patrol was forced to withdraw, he succeeded in reaching the Battal ion Observation Post with an urgent message from his patrol leader. His aggressive fighting spirit, courageous efforts and outstanding devotion to duty in the face of grave danger were in keeping with the highest traditions of the United States Naval Service."

CITATION:

"For conspicuous callantry and intrepidity as Leader of a Fire Team, serving with Company G. Second Battalion, Seventh Marines, First Marine Division, during action against enemy Japanese forces at Okinawa, Ryakyu Islands, on 13 May 1946. Fighting furiously throughout a vigorious assault against a heavily defended hostile position, Corporal Tyler repeatedly exposed himself to the enemy's shattering small-arms fire to locate camouflaged machine-gun positions scattered throughout the area and, fearlessly leading his men forward, boldly directed their deadly fire against the entrenchments. With a well-concealed pillbes inflicting heavy casualties on our troops during the sustained advance, he voluntarily made his way forward of our lines and, locating the source of the blistering shellfire, singlehandedly charged the emplacement, destroying the weapon and accounting for the entire crew. Fatally struck down while returning to his own lines, Corporal Tyler, by his inspiring leadership, introoid courage and valiant devotion to duty in the face of grave peril, had centributed materially to the success of the bitterly fought Okinawa campaign and upheld the highest traditions of the United States Naval Service. He gallantly gave his life for his country."
